Early September 2023

UCAS Apply (website) opens for applications for 2024 entry (and deferred entry in 2025).

15 September 2023

Applicants for Law must have registered for the LNAT Assessment (to be taken by 16 October 2023)

29 September 2023

Applicants must have registered for any pre-registration required assessments.

Remember to submit by 18:00 (6.00pm) UK time. Students that are required to submit a transcript should also submit by this date.

02 November 2023

Deadline for [Additional Applicant Information Form](#) (AAIF) for all applicants.

Deadline for submission of [written work](#) (if your course requires this).

Deadline for Disability Adjustments and Allowances at Interview Form for relevant applicants (this form will be circulated by email and should be returned using the Applicant Document Upload Form).

Mid November - late November 2023

If you are being called to interview, you will receive an email from the College with full details of arrangements. We will give applicants as much notice as possible, and this can vary based on subject. All applicants should be notified by 1 December 2023, so please do not contact our office before then to enquire about the status of your application.

Late November (23 November onwards)

College-Registered Assessments to take place. If you are invited to sit one of these assessments, you will be notified via email in mid-November.



December 2023

Interviews. The majority of interviews will take place online between 4 December and 15 December.

Late January 2024

We will send you an email telling you the outcome of your application and UCAS will be updated:

We may offer you a place, conditional or unconditional, at Newnham College.

We may tell you that your application was unfortunately unsuccessful and that you have not obtained a place at Newnham or any other Cambridge College.

If we are unable to offer you a place, but think that other Colleges may be interested in your application, we will have placed your file in the Winter Pool. You may be selected by another College, who should also contact you on the same day.

Early February 2024

Deadline for submission requests for feedback on unsuccessful applications. It is our policy to send this feedback to the applicants' schools or colleges, because we feel that teachers are best placed to put the information in context. If an applicant is no longer at school or college, we are happy to send the feedback directly. We regret that, due to GDPR, we are unable to engage in any discussion with parents, unless we have the written permission of the applicants concerned.
